The National Lotteries Commission approved Kids Haven to host a quarterly draw to incentivise and reward our regular monthly donors.

The Draw dates for 2019 are as follows:

13 January 2019	R 10 000
13 April 2019	R 10 000
18 July 2019	R 10 000
13 October 2019 (Our Birthday)	R 10 000

Terms and Conditions:

1. The Friends of Kids Haven Monthly Givers Group is open to any individual or small company MONTHLY donor who would like to participate.
2. A monthly donor is defined as a donor who is contributing a minimum of R 100 per month, every month, for a minimum of 3 months. Only monthly donors are eligible to enter each draw. Eligible donors are automatically included. Once-off annual payments are not eligible for the draw.
3. Donors who contribute more than R100 per month will be entitled to entries totalling the multiples of R100 donated, into the quarterly draw. For example, donors who contribute R100 receive one entry, R200 = two entries, R 1 000 = ten entries.
4. Each monthly donor is allocated a unique number/ unique numbers depending on the donated amount. The unique number will constitute a ticket. The draw takes place on the prescribed date by a member of the Kids Haven EXCO and an invited guest. The winner is contacted and details published on Kids Haven social media and in the Benoni City Times. The winnings are paid over to the winner within 30 days of the draw.
5. Two winners have been drawn in 2018 – Julia Henkel-Kerr on 13 August 2018 and Jafta Allies on 13 November 2018
